Accepted digital image file formats: TIF, PSD, EPS, JPG, GIF

Color Space: RGB

File Size: 6MB or larger

Image Resolution: Long side of image 7 inches at 300 pixels per inch

(150 DPI) or 2100 pixels.

All submitted images to be in focus, no reflections. Image of artwork should fill frame as much as possible, without distortion. Images that do not meet the specifications will not be used.

If you are using a cell phone camera please select the largest file size possible.
